## Harassed PU student succumbs to burns

A 17-year-old girl, who was undergoing treatment at Manipal hospital after allegedly attempting suicide over an obscene video made by two classmates, died on Monday. It's alleged that the PU student from Jagaluru taluk was blackmailed by two students and tried to end her life.

She was admitted to the taluk hospital and later was shifted to Davanagere district hospital for treatment.

Later, she was taken to a private hospital in Manipal for further atment, but suc-

mbed. During the treatment, the girl had given a video statement which went viral on social media.

She has alleged that two youths who had become her friends, had mixed some inebriated substance in the food bought from a bakery and she became uncon-
